6) Financial Results 2019-2020

WHEREAS the Champlain Regional College financial statements are in the process of being audited by the firm Raymond Chabot Grant Thornton in accordance with the accounting standards for public sector entities; and

WHEREAS Champlain Saint-Lambert annual financial results will be integrated to the annual financial statements Champlain Regional College;

BE IT THEREFORE RESOLVED that the Governing Board adopts the 2019-2020 financial statements as tabled; and

BE IT THEREFORE FURTHER RESOLVED that the Governing Board recommends to the Board of Governors that the Champlain Saint-Lambert financial results be integrated to the Champlain Regional College 2019-2020 financial statements.
