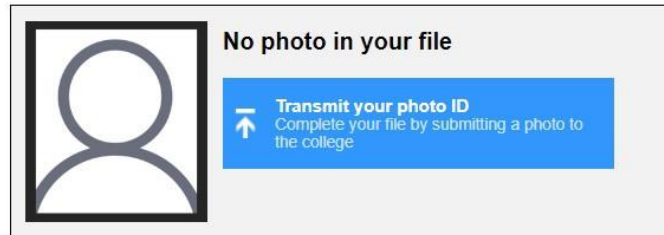

Étapes 1 et 2

Personal File for Students

Photo ID

1 Select a photo that meets the criteria


You are about to transmit your photo to the college. This photo will be used for your student ID card among other things and used for communication purposes on the Omnivox platform.

You need to provide a recent photo, taken within the last six months, that meets the criteria, otherwise you will be required to submit a new photo.


Selection criteria for the photo:

- **Appear alone**
You must be alone in the photo. You must be the main subject in the photo.
- **Eyes and position of the face**
You must be facing the camera. Your head must be straight and your face unobstructed. Your face must be centered within the frame of the photo.
- **Photo quality**
The photo must be clear, the focus on your face.
- **Lighting / contrast / colours**
The photo must be neither overexposed or under-exposed. It must be properly contrasted, without shadows on your face or in the background.
- **Background**
The background must be solid, in a clear colour (white, light blue or light grey).
- **The head**
Hats and sunglasses are not permitted. Note if you wear glasses, it is not necessary to remove them.



5 Transmit a photo of a supporting document

In order to generate your student identification card, the Champlain College St-Lambert must validate your identity. To do so, you must provide a supporting document.


The supporting documents accepted are a **health insurance card**, a **driver's license** or a **passport**.

Note that once your identity is validated, the supporting document you have transmitted will be destroyed from the system in order to ensure the safety of your information.

Selection criteria for the photo:


- **Type of document**
The supporting document must be a health insurance card, a driver's license or a passport.
- **Content legible**
The text on the supporting document must be clear and legible.
- **Full view of the document**
The supporting document must be photographed in its entirety.
- **Quality of the photo**
The photo of the supporting document must be clean with the focus on your face.

7 **Frame the photo from the supporting document**



8 Verify the selection criteria

Here is the supporting document that will be transmitted at the college in order to validate your identity.

Ensure that the photo respects the selection criteria.



Selection criteria for the photo:

- **Type of document - Health insurance card**
The supporting document must be a health insurance card.
- **Content legible**
The text on the supporting document must be clear and legible.
- **Full view of the document**
The supporting document must be photographed in its entirety.
- **Quality of the photo**
The photo of the supporting document must be clean with the focus on your face.

Submit your photo as well as a supporting document in order to have them validated by the college. Once approved, your photo will be linked with your student record. If it is rejected, you will be invited to transmit a new photo.

Note that your identity will be verified at the time of giving you your student identification card. The photo from the supporting document you are about to transmit will be automatically deleted from the Omnivox system once your identity has been validated.

Transfer your photo and the supporting document at the college now.
