# 5) Proposed Changes to Bylaw 7 (Student Admission to Academic Programs) Resolution No.: LAM-2023-007

Donald Shewan spoke to this item.

**WHEREAS** the last revision of Bylaw 7 Concerning Student Admission to Academic Programs took place in January 2019; and,

**WHEREAS** the changes from Chapter 1 to Chapter 2 of the Colleges Act provides for a local admission process;

**WHEREAS** the adoption of Law 14 (*La Loi sur la langue officielle et commune du Québec, le français*) mandated a change to the admissions process in all Englishlanguage Cégeps;

**WHEREAS** the Registrars of the Constituent Colleges worked together to draft the revised bylaw so as to be compliant with provincial regulations;

**WHEREAS** the Commission of Studies has endorsed the proposed modifications.

**BE IT THEREFORE RESOLVED** that the Governing Board of Champlain College Saint-Lambert recommend the proposed modifications to Bylaw 7 Concerning Student Admission to Academic Programs, for application as of the Fall 2024 semester to the Board of Governors of Champlain Regional College for adoption.

The Director of the Constituent College has committed to raise concerns with the SMC (Senior Management Committee) about the Bylaw 7 comments received concerning Continuing Education and will report to the Governing Board as soon as possible.
