5) IPEAP (Institutional Policy on the Evaluation of Academic Programs) Resolution No.: LAM-2023-020

Donald Shewan invited English Faculty member Dianne Bateman to speak to this item.

Dianne Bateman presented the working process used in the creation of document C2023-24-14, the Institutional Policy on the Evaluation of Academic Programs (IPEAP - formerly IPMAP). The document was sent to all members of the Commission of Studies and was made available to all faculty for review. The policy follows the requirements and recommendations of the CEEC for program evaluation. The General Education disciplines are integrated into the program evaluation cycle for each program and the process is designed to be ongoing throughout each academic year. The continuous process will ensure that all criteria will be examined in a 5-year cycle. The document will serve as the principal mechanism to ensure that academic programs at Champlain College Saint-Lambert maintain high academic standards, foster a culture of continuous improvement, and ensure accountability in delivering quality college education. The policy is intentionally designed to harmonize with and support the college's Strategic Plan, Student Success Plan, and Institutional Policy on the Evaluation of Student Learning (IPESL). Together, these policies comprise Champlain College Saint-Lambert's Quality Assurance System. The IPEAP establishes the procedures for the ongoing evaluation of academic programs, program changes, and the implementation, revision, and adjustment of the policy itself.

WHEREAS the CEEC (Commission d'évaluation de l'enseignement collegial) has recommended substantive revisions to the IPMAP (Institutional Policy on the Management of academic Programs; and

WHEREAS the College is obliged to respond to these recommendations; and

WHEREAS a subcommittee of the Commission of Studies produced a substantially modified document and proposed renaming it the IPEAP (Institutional Policy on the Evaluation of Academic Programs)

WHEREAS the Commission of Studies has unanimously recommended at its meeting of May 30, 2024, that the Governing Board adopt the renamed and revised policy,

BE IT THEREFORE RESOLVED that the Champlain College Saint-Lambert Governing Board accept the IPEAP as revised and invite the Administration to inform it of the response by the CEEC.
